Purpose

To establish the conditions within which Grey Highlands Public Library provides space for art by local community artists.

Eligibility

1. Applications for exhibits must be made to library staff and will be processed in such a manner as to provide a variety of displays for the public.
2. The use of the library space is for display purposes. Receptions and exhibit openings are not permitted.
3. Library exhibits are viewed by children and adults who have various degrees of maturity; therefore, exhibits on display must reflect community standards established by the library board.
4. Library personnel reserve the right to reject any exhibit in full, or in part. Priority will be given to artists who live in Grey County.
5. Permanent use of the display area is not permitted by any individual. Exhibits will normally be limited to a period of one month with definite display dates established in advance.
6. Exhibits are unsupervised and are accessible to the public throughout Library open hours, except when the space is required for Library purposes.
7. It is the responsibility of the exhibitor to set up and remove the exhibit in accordance to the established schedule. If assistance is required, it is the exhibitor's responsibility to provide such assistance as Library staff will not normally assist in the set up or removal. It is understood that the artist will be responsible for costs to repair any damages to walls resulting from exhibits.
8. Artists are encouraged to post a statement about their works.
9. The Library's insurance policy covers only items owned by the library. All exhibitors are required to sign an Exhibit/Display Agreement which releases the library from responsibility for any items in the exhibit.
10. Fees and commissions will be reviewed annually.

Agreement for Display of Art- Grey Highlands Public Library

This agreement is for the rental of wall space in the _____ of the _____ Branch of the Grey Highlands Public Library to display works of art. By signature, the agreement is made between the undersigned Artist (herein called the "Artist") and Grey Highlands Public Library. This agreement stipulates that the Artist contracts for the rental use of specific space(s) and/or services at Grey Highlands Public Library under the following terms and conditions:

Conditions:

1. Applications for exhibits must be made to library staff and will be processed in such a manner as to provide a variety of displays for the public.
2. The use of the library space is for display purposes only. Receptions and exhibit openings are not permitted.
3. Library exhibits are viewed by children and adults who have various degrees of maturity; therefore, exhibits on display must reflect community standards established by the library board. Applicants will submit photos of art to be displayed in advance for approval.
4. Library personnel reserve the right to reject any exhibit in full, or in part. Priority will be given to artists who live in Grey County.
5. Permanent use of the display area is not permitted by any individual. Exhibits will normally be limited to a period of one month with definite display dates established in advance.
6. Exhibits are unsupervised and are accessible to the public throughout Library open hours, except when the space is required for Library purposes.
